# **SASK opens a Call for Expression of Interest**

SASK is seeking Expressions of Interest from potential organisations to partner in SASK's operations to promote workers' rights in the world of work during the next SASK Programme period 2026-2029.

The purpose of this Call is to introduce organisations and their potential modes of operation to SASK. SASK reserves full discretion related to the process and decisions for its future partnerships.

### What is SASK?

Trade Union Solidarity Centre of Finland SASK is the workers' rights organisation of the Finnish trade union movement. By strengthening the trade union movement and the position of workers in the Global South, SASK aims at enforcing international core labour standards, promoting decent work, and living wages and thus supporting struggle against poverty and social inequality. In addition to trade union rights, SASK's strategic themes of gender equality and non-discrimination, just transition, as well as digitalization and new forms of work, are emerging as key themes in SASK's operations.

By decent work SASK means that all people should have access to regulated, safe and healthy work that guarantees a living wage. By core labour standards SASK refers to <u>the International Labour Organization ILO</u>. Relative poverty can be reduced through collective agreements and social policies that enable the working population to gain their share of national development and wealth. Poverty and inequality are also reduced by promoting social inclusion and increasing people's opportunities to take an active part in social processes. The Call for Expression of Interest is required to be submitted via the SASK online template only. The Call for Expression of Interest for the programme period 2026-2029 closes on **August 31st, 2024**.

After the closing of the Call for Expression of Interest, SASK will assess the received Expressions of Interest and contact all organisations prior to the start of the programme period 2026-2029.
